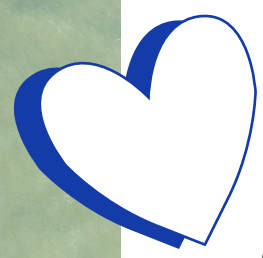

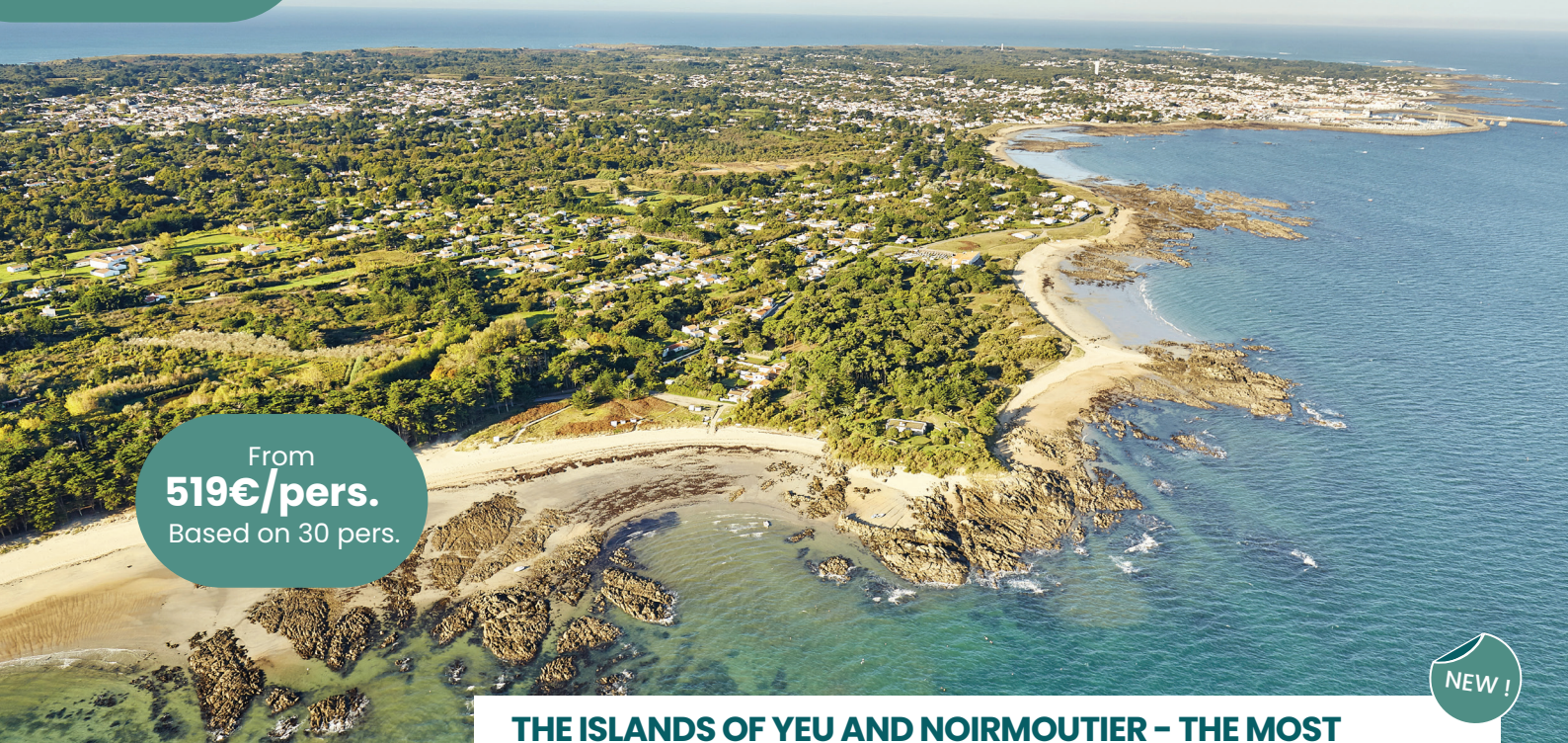

THE ISLANDS OF YEU AND NOIRMOUTIER – THE MOST BEAUTIFUL SPOTS OF THE ATLANTIC

A fantastic way to explore our two Vendean islands. After a day on the Île d'Yeu, discover the charms of the Île de Noirmoutier.

April to October
(except July/August)

Tour highlights

- Complementary visit to our Vendean islands,
- Discover local "maraîchines" gardening traditions and regional products.

Where to stay

- A 3-star hotel set in the heart of a pine forest, a real little corner of paradise.

DAY 1 – Vendée Breton Marsh (26 km)

Visit an oyster farm and discover all the secrets of oyster farming. After the visit, why not **sample some delicious oysters from the region?**

DAY 2 – Île de Noirmoutier (88 km)

A guided coach tour of the Île de Noirmoutier, following an unusual route filled with the scent of pine trees and the fresh sea air: **the Bois de la Chaise and its villas, Noirmoutier en l'île and its narrow streets lined with white houses...** **Visit to a salt marsh**, learn more about the work of the salt worker and the different tools used.

DAY 3 – Île d'Yeu (54 km)

High-speed ferry crossing. Shopping in the narrow streets of Port Joinville. **Explore the Île d'Yeu by coach** : Port Joinville, the Sabias, the Côte Sauvage, Port de la Meule, Plage des Vieilles, Pointe des Corbeaux...

DAY 4 – Vendée Breton Marsh (26 km)

Visit the eco-museum Le Daviaud which takes an immersive tour through a preserved natural setting. Take part in a demonstration of traditional skills or perhaps learn a few maraîchine (local music) dance steps? **Guided walking tour to discover the history of the Ile de Sallertaine, a village awarded with the 'Ville et Métiers d'Art' award.**

A FOCUS ON THE HISTORICAL AND CULTURAL VENDÉE

From prehistoric times to the Second World War, the landscape of the Vendée has evolved, preserving precious reminders of the periods that have forever marked the history of its inhabitants. Set off on a tour to discover the different heritage sites in the region.

DAY 1 – Logis de la Chabotterie (22 km)

A visit to the Logis de la Chabotterie: a major site during the Vendée War and where General Charette was arrested. La Chabotterie remains one of the finest examples of a dwelling house found in the Bas-Poitou region (today known as the Vendée).

DAY 2 – Two outstanding abbeys Nieul sur l'Autise and Maillezais (160 km)

A guided tour of the 12th-century Abbaye de Nieul sur l'Autise, the birthplace of Eleanor of Aquitaine who was not only Queen of France (1137 to 1152) but also Queen of England (1154 to 1189). Then **cruise on flat-bottomed boats through the Marais Poitevin,** followed by **a guided tour of l'Abbaye de Maillezais,** which reveals its unique Romanesque architecture well known in the Poitou-Saintonge.

DAY 3 – Historial de la Vendée and Haras de la Vendée (52 km)

Visit to the Historial de la Vendée: explore 7,000 years of history in an original and entertaining museum that travels through the centuries. **Then it's off to the Haras de la Vendée,** a site dedicated to the equestrian arts. Discover the world's only horse conservatory and the unique skills of National Stud's saddler makers and farriers.

DAY 4 – Château de Tiffauges (52 km)

Visit the Château de Tiffauges, the largest medieval site in the west of France. This former residence of Gilles de Rais, Marshal of France and comrade-in-arms to Joan of Arc, is full of secrets and inspired the legend of a certain Bluebeard...

DAY 1 – Saint Gilles Croix de Vie (10 km)

Visit to the 'Escale Pêche' maritime museum, a unique place to learn about the history of fishing. Then a visit to the marina and fishing port, which is the main sardine port on the Atlantic coast. This is followed by a visit to **L'Atelier de la Sardine** (the Sardine Workshop), which retraces the savoir-faire of La Perle des Dieux and **enjoy sampling some of their produce**. A warm welcome at the hotel, is followed by a local wine tasting session.

DAY 2 – Île d'Yeu (54 km)

Arrive by boat at Port Joinville and discover its colourful port. **Set off on a guided tour of the island either by coach or tourist train:** heading toward the Sabias along the wild coastline, the Port de la Meule, the Romanesque church of Saint Sauveur, the Plage des Vieilles and the Pointe des Corbeaux...Return crossing to the mainland.

DAY 3 – Marais breton vendéen and Île de Noirmoutier (95 km)

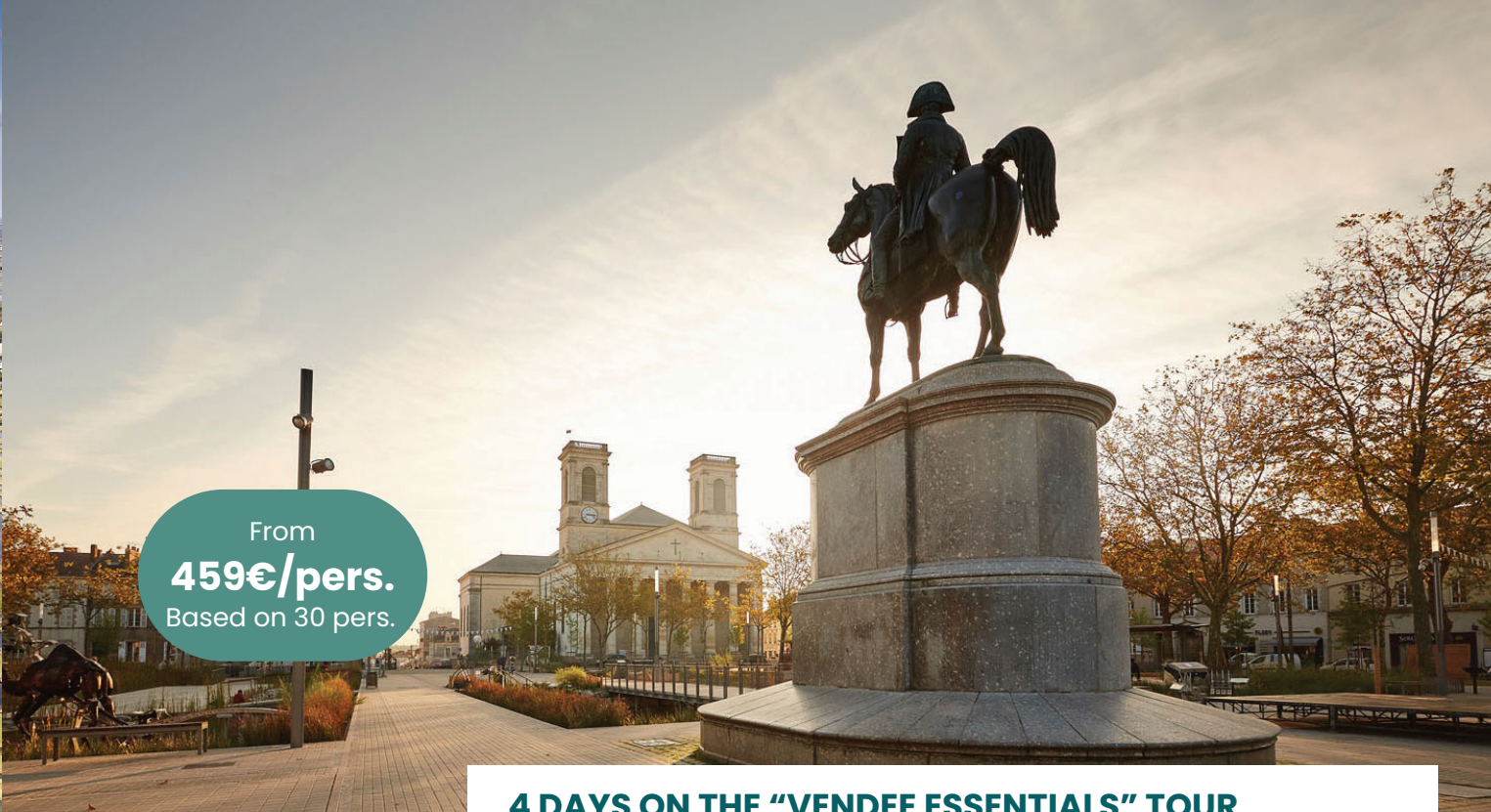
Guided tour through large pastures dotted with estuaries and canals, small traditional ports and fisheries. Departure for the Île de Noirmoutier, via the Passage du Gois or the bridge. **A guided coach tour of the island:** via the Bois de la Chaise with charming historic villas, the Plage des Dames... **Guided tour of a salt marsh** with a salt-worker.

DAY 4 – Les Sables d'Olonne (85 km)

A guided tour of Les Sables d'Olonne, to discover the town's maritime past. A stroll along the sea front. **Then it's off for a boat trip onboard "La Messaline"**, a 17-metre wooden boat, to explore the rugged, untamed coastline.

DAY 5 – Le Port de la Guitière – Talmont Saint Hilaire (55 km)

A guided walk that heads towards the Payré Estuary, listed as a Grand Ensemble Naturel (a vast natural environment) for its stunning beach - Plage du Veillon. In the village of La Guitière, there is **a visit of an oyster farm**, the oyster beds and then a chance to **sample some local oysters**.

DAY 2 - Marais Breton vendéen and Île de Noirmoutier (176 km)
A guided tour through large pastures peppered with estuaries, canals, small traditional ports and fisheries. **Guided tour of an oyster farm and oyster and wine tasting**. Departure for Île de Noirmoutier, either via the Passage du Gois or the bridge. Then **a guided coach tour of the island**: taking in the Bois de la Chaise with its charming historic villas,... Followed by **a guided tour of a salt marsh** accompanied by a salt-worker.

DAY 3 - Puy du Fou (126 km)
Experience an incredible day at Le Puy du Fou and an unforgettable journey back in time. Discover the great daytime shows, villages and the hundred-year-old forest. At dusk, admire **the night-time show 'Les Noces de Feu'** and witness the most romantic of weddings between the violin muse and the virtuoso pianist.

DAY 4 - La Roche sur Yon (8 km)
A guided tour of La Roche sur Yon. This small town became the administrative centre for the Vendée by order of Napoleon in 1804. Discover the old quarters, Place Napoléon, its mechanical bestiary...

From the canals of the Venise Verte to the Baie de l'Aiguillon, passing the historic towns and vineyards of the southern Vendée, a perfect way to explore the Marais Poitevin during your stay.

DAY 2 - Southern Vendée (35 km)

A guided tour of l'Abbaye de Maillezais, a former fortress-cathedral and one of the founding abbeys of the Marais Poitevin. **Followed by a guided tour in a traditional boat**, a delightful way to relax and enjoy the unspoilt countryside. And finally, **a guided tour of a charming Renaissance masterpiece, that of the Château de Terre-Neuve.**

DAY 3 - Luçon (106 km)

A guided tour of Luçon, with its splendid Notre Dame de l'Assomption cathedral and its cloister, which was promoted to a cathedral status in 1317 by Pope John XXII. Then **a tour of an oyster farm** and learn more about the skills involved in Vendée Atlantique oyster farming before **sampling some.**

DAY 4 - Fontenay le Comte (5 km)

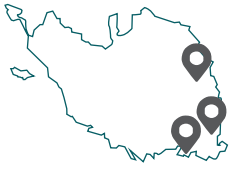
Guided tour of Fontenay le Comte, a 'Town of Art and History', renaissance and medieval, an architectural gem, listed as one of the «Most Beautiful Detours in France» in 2020. Fontenay le Comte boasts several private mansions and magnificent residences.

DAY 2 - Vouvant - Mervent - Pissotte (46 km)
The guided tour begins at Vouvant, listed as one of the 'Most Beautiful Villages in France'. This medieval town sits neatly on a bend of a meandering river. Then it's off to visit the Mervent-Vouvant state forest, accompanied by a forestry guide. This is followed with a visit to an AOC wine estate part of the Fiefs Vendéens Pissotte appellation: and ending with a wine tasting session of the estate's wines.

DAY 3 - Faymoreau - Foussais-Payré (52 km)
A walking guided tour through the 'corons' and the old mining village of Faymoreau. Then a stop at the Chapelle des Mineurs to discover the 19 stained-glass windows created by Carmelo Zagari. And finally, a guided tour of Foussais Payré, that reflects two periods of architectural splendour.

DAY 4 - Rives d'Autise - Damvix (52 km)
Today begins with a guided tour of the Abbaye de Nieul sur l'Autise. This Royal Abbey contains the only Romanesque cloister in the west of France which have been preserved in its entirety. Then a guided boat trip on the canals of the Marais Poitevin, Grand Site de France and Regional Nature Park.

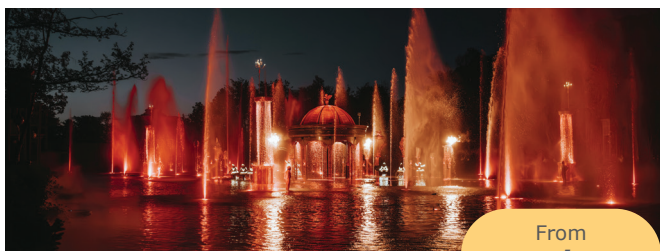

Article R211-3

All offers and sales of the services referred to in article L. 211-1 must be accompanied by appropriate documents which comply with the rules set out in this section.

Article R211-3-1

The exchange of pre-contractual information or the provision of contractual terms and conditions shall be in writing. This may be done electronically. The name or company name and address of the organiser or retailer must be mentioned, along with details of its registration in the register provided for in article L. 141-3 or, where applicable, the name, address and details of the registration of the federation or union mentioned in the second paragraph of article R. 211-2.

Article R211-4
Prior to the conclusion of the contract, the organiser or retailer must provide the traveller with the following information:

1° The main characteristics of the travel services:

a) The destination or destinations, the itinerary and the periods of stay, with the dates and, where accommodation is included, the number of nights included;
b) The means, characteristics and categories of transport, the places, dates and times of departure and return, the duration and place of stopovers and connections. When the exact time has not yet been fixed, the organiser or retailer will inform the passenger of the approximate time of departure and return;

A statement indicating that the traveller is obliged to communicate any non-conformity that he observes during the journey or stay in accordance with II of Article L. 211-16;

6° Where minors, unaccompanied by a parent or other authorised person, are travelling on the basis of a contract including accommodation, information enabling direct contact to be established with the minor or the person responsible for the minor at the minor's place of stay;

7° Information on available internal complaint handling procedures and out-of-court dispute settlement mechanisms and, where applicable, on the entity to which the professional belongs and on the online dispute settlement platform provided for in Regulation (EU) No 524/2013 of the European Parliament and of the Council; with regard to the packages defined in e of 2° of A of II of article L. 211-2, the professional to whom the data are transmitted informs the organiser or retailer of the conclusion of the contract giving rise to the creation of a package. Article R211-7

Unless otherwise stipulated, the transferee must inform the organiser or retailer of his/her decision by any means allowing a recorded delivery, no later than seven days before the start of the trip. Under no circumstances is this transfer subject to prior approval by the organiser or retailer.

Article R211-8

Where the contract expressly provides for the possibility of price revision, within the limits set out in article L. 211-12, it shall specify the precise methods for calculating price variations, both increases and reductions, in particular the amount of transport costs and related taxes, the currency or currencies that may affect the price of the holiday or trip, the proportion of the price to which the variation applies, as well as the exchange rate of the currency of the package, he must provide when establishing the price stated in the contract. In the event of a reduction in the price, the organiser or retailer has the right to deduct its actual administrative expenses from the reduction due to the traveller. At the request of the traveller, the organiser or retailer shall provide proof of these administrative expenses.

Article R211-9
When, before the traveller's departure, the organiser or retailer is obliged to make a change to one of the essential elements of the contract, if he cannot meet the specific requirements mentioned in article R. 211-9, or if the event of a price increase of more than 8%, he shall inform the traveller as soon as possible, in a clear, comprehensible and visible manner, on a durable medium: 1° Of the proposed changes and, if applicable, of their repercussions on the price of the journey or stay;

2° A reasonable time period within which the traveller must inform the organiser or retailer of his decision;

3° The consequences of the traveller's failure to reply within the time limit set;

4° If applicable, the other service offered, as well as its price.
If the changes to the contract or the substitute service result in a reduction in the quality of the trip or holiday or in its cost, the traveller is entitled to an appropriate price reduction.

If the contract is cancelled and the traveller does not accept another service, the organiser or retailer shall refund all payments made by the traveller or in his/her name as soon as possible and no later than fourteen days after the cancellation of the contract. In the case provided for in III of article L. 211-14, the additional compensation that the passenger is likely to receive is at least equal to the penalty that he would have paid if the cancellation had been caused by him on that date.

Article R211-10
The organiser or retailer shall make the refunds required under II and III of article L. 211-14 or, under I of article L. 211-14, refund all payments made by the traveller or made by or on behalf of the traveller less the necessary costs of settlement. These refunds to the traveller are made as soon as possible and no later than fourteen days after the cancellation of the contract. Prices are quoted net of VAT, in Euros and are valid for 2025. The price of the trip or holiday must be stipulated by the reservation staff at the time of booking. Any complaints concerning the price of the trip may be taken into consideration upon return. It is therefore the customer's responsibility to assess whether the price is appropriate before departure. Prices are calculated based on 30 people, unless otherwise stated in the description or quotation. A group of less than 20 people is not considered as a group and is not eligible for the group rates. A surcharge will be calculated to establish an individual rate. Prices on the website include tourist tax and application. Prices do not include coach transport, cancellation insurance, 20€ booking fee for stays of 1

night or more, single room supplement, personal expenses and any other service not mentioned in the itinerary. Free admission for stays of 1 night or more: 1 free entry for every 20 paying guests, the second free entry for every 40 paying guests, except for the single room supplement. Free admission for day trips: 1 free admission for every 30 paying guests, 2 for 47 paying guests or more.

3 – Quotes

Each quote is tailor-made. The quote sent is under no circumstances the equivalent of an option, unless expressly stated on the quotation. Quotes are subject to availability at the time of the final booking. On receipt of your 'bon pour accord' accepting the quote, a booking form is drawn up with a request for a deposit of 25% of the balance and the options are placed with the service providers.

4 – Booking and payment

Reservations become firm when a deposit that correspond to 25% of the full holiday price, the booking fee, cancellation insurance (optional) and a copy of the booking form signed by the customer have been returned to the Vendée Expansion - SEM marketing department. The complete list of the names of the group, including the number of participants and the precise list of people sharing rooms, must reach the Vendée Expansion marketing department 2 months before the arrival of the group; as well as the choice of menus (one choice for the whole group). The balance will be calculated according to the final number of people. A pro-forma invoice is drawn up by Vendée Expansion - SEM will then be sent. The balance payment must be paid in order to receive the travel pack. Payment must be made at least 30 days before the start of the holiday and the final list of participants must be provided. Customers who have not paid the balance by the agreed date are considered to have cancelled their trip or holiday. The service will then be resold, and no refund will be made.

In the case of late bookings made less than 30 days before the start of the holiday, full payment will be required at the time of booking. The payment schedule and balance are subject to the application of the general terms and conditions of sale.

5 – Travel vouchers

The customer must present the service provider(s) with the travel vouchers corresponding to the services booked. The vouchers must be handed to the service provider(s) by the customer upon arrival. If some of the services mentioned on the Voucher are not provided through no fault of the customer, the customer must obtain a certificate/proof from the service provider to benefit from refund or a commercial agreement of the service provider. This certificate must contain the agreement of the service provider and needs to be sent as soon as possible to Vendée Expansion - SEM. SAEML Vendée Expansion will verify the validity of any certificate not bearing the agreement of the service provider and the final agreement of the service provider within a period of 8 days. Any additional services requested by the customer, not mentioned in the travel vouchers, must be paid directly to the service provider on site.

6 – Arrival

The customer must arrive on the day and at the time specified on the travel voucher(s). In the event of a late or delayed arrival or a last-minute internet payment, the customer must notify the service provider(s) whose address and telephone number appear on the travel voucher(s) directly. Any services not consumed as a result of this delay will remain due and cannot be refunded.

7 – Modification

By the customer: this must be submitted to Vendée Expansion - SEM, which reserves the right to either refuse or accept it. Any modification to the signed contract will result in cancellation charges according to the terms of the contract, conditions of article 8. Any postponement of the date will be considered as a cancellation and will result in the application of charges according to the scale in force in article 8. Due to the seller: these are subject to the application of articles R. 211-9 and R. 211-10 of the French Tourism Code.

8 – Cancellation

By the customer (except in the cases mentioned in article R. 211- 9 of the French Tourism Code): this must be notified by registered letter, e-mail or fax to the Vendée Expansion - SEM marketing department. The date of cancellation is the date of receipt of the aforementioned documents. Total cancellation by the customer, regardless of the date of cancellation, will incur a 200€ handling fee. In addition to the booking and insurance fees, the amount of refund held varies according to the nature of the trip and stay and the date on which the cancellation is made (partial or total): * more than 60 days before departure, Vendée Expansion - SEM reserves the right to keep part of the deposit in order to compensate its services; * less than 60 days before the right to invoice services according to their own cancellation conditions. The deposit will be deducted pro rata from their invoice. * 60 to 31 days before the start of the holiday, 30% of the total price of the holiday, * 30 to 21 days before the start of the holiday, 50% of the total price of the holiday. * From 20 to 8 days before the start of the holiday, 75% of the total price of the holiday. * Less than 7 days before the start of the holiday or no-show, 100% of the total price of the holiday. For any cancellation involving a reduction of more than 10 people compared with the original booking, and made less than 60 days before departure, without having notified SAEML Vendée Expansion by e-mail, fax or post before this date, the following penalty will be applied: €20 per night and per person. Cancellation conditions specific that apply to Puy du Fou entrance tickets: in the event of partial cancellation by one or more members of the group, after the pro-forma invoice has been issued, Puy du

Fou tickets cannot be returned, refunded or exchanged. The full amount of the Puy du Fou ticket reservation will be due. By the seller: cancellation conditions by the seller are subject to the provisions of the French Tourism Code.

9 – Insurance

Vendée Expansion - SEM draws the customer's attention to the possibility of taking out an insurance policy covering the consequences of cancellation with our partner Assurino. Customers are responsible for all damage caused by themselves. They are advised to check whether their personal insurance covers them for 'holiday accommodation'. If not, it is strongly recommended that they take out such insurance. The services sold by Vendée Expansion - SEM do not include any cancellation insurance. However, customers are strongly advised to take out holiday cancellation insurance. IMPORTANT: The insurance must be taken out on the day of booking and no later than the day before the first day of enforcement of the penalties rate. The general conditions governing this insurance regarding the terms and conditions as well as the extent of cover, and the customer's obligations in the event of a claim, will be provided with the travel documents.

10 – Cutting the trip/holiday short

If the customer cuts their holiday/trip short, no refund will be made.

11 – Party size and animals

The contract is drawn up for a maximum group size, if the number of participants exceeds the agreed number of people, the service provider may refuse to accept additional clients. The client must inform Vendée Expansion - SEM if they are accompanied by a pet. Under the Expansion - SEM will work the service provider(s) concerned and will inform the client in the event of specific reception conditions. If the customer fails to comply with these conditions, the service provider may refuse the holiday. No refund will be made.

12 – Hotels

Prices include room and breakfast, half board or full board depending on the chosen programme. Unless otherwise indicated, drinks are not included with meals. If a customer occupies a room designed for two people on their own, they will be charged a supplement known as the 'single room supplement'. The room must be vacated by noon on the day of departure.

13 – Complaints

Any complaint relating to the non-execution or poor execution of the contract must be addressed to Vendée Expansion - SEM in writing by registered letter with as soon as possible. After referring the matter to the Vendée Expansion - SEM marketing department, and in the absence of a satisfactory response or after 60 days, the customer may refer the matter to the Médiateur du tourisme et du Voyage (MTV), whose contact details are as follows: MTV Médiation Tourisme Voyage BP 80 303 - 75 823 Paris Cedex 17. 14 – Jurisdiction

Any dispute will fall within the jurisdiction of the court of the registered office of Vendée Expansion - SEM.

15 – Liability/over booking

Vendée Expansion - SEM cannot be held responsible if a service provider has sold more holidays than are available. In all cases, the vendor cannot be held responsible for unforeseen events, circumstances beyond their control or the actions of any person not involved in the organisation or running of the trips or holidays.

16 – French language

In accordance with the provisions of law no. 94-665 of 04 August 1994, as amended, the documents presented or given to customers are written in French. However, foreign language translations of all or part of these documents may be carried out. In all cases, the client and Vendée Expansion - SEM agree that the documents drawn up in French are authoritative and, in the event of contradiction with other documents, take precedence over the latter.

17 – Protection of personal data

The customer is informed that the personal data communicated when the contract is drawn up is intended for use by Vendée Expansion - SEM. This data is processed exclusively for the purposes of executing the said contract, to provide the services booked, to send statements and invoices, and to collect payments. Vendée Expansion - SEM may communicate the customer's personal data to third party subcontractors in the context of service provision activities. These service providers are contractually obliged to respect an obligation of security and confidentiality of the client's data and undertake to this end to implement appropriate technical and organisational measures. Vendée Expansion - SEM guarantees the customer that their data will under no circumstances be communicated to commercial partners. 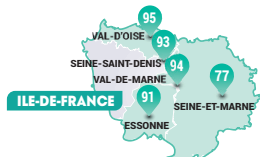
